Wisconn Valley Way

Wisconn Valley Way is a new north-south roadway between County KR and WIS 11. This multilane, controlled-access roadway will accommodate development traffic and control access to manage safety and mobility. The location and design of Wisconn Valley Way is consistent with an agreement between WisDOT and the Village of Mount Pleasant outlining long-term frontage road development and access management.

Right of Way Acquisition and Access Rights

The Village of Mount Pleasant is acquiring and paying for all right of way, including relocations, needed to build the necessary road improvements (except for WIS 11 west of I-94, which WisDOT will acquire and purchase). Representatives from the village's and WisDOT's real estate teams are available at this meeting to explain the process and answer questions.

Zoning, development construction and projected traffic volumes require access control to maintain safety and mobility. The village will purchase access rights on County KR, County H, Braun Road and International Drive. On behalf of WisDOT, the village will also purchase and acquire access rights on Wisconn Valley Way, WIS 11 and East Frontage Road.

Concurrent Area Roadway Projects

WIS 20/County C Roundabout: *March to October 2018*

WIS 20 will have one lane open in each direction during construction; County C will fully close north of WIS 20 until July 2018, and for several weeks in fall. County C traffic will be detoured to WIS 20 and West Frontage Road.

WIS 20, County H and County A Rehab: *March to June 2018*

Construction impacts include the closure of County A, and the nighttime and one full weekend closure of County H (traffic will be detoured); narrow travel lanes; and some flagging operations.



Project Description

In November 2017, WisDOT took temporary jurisdiction over the following roadways:

- County KR between
 I-94 and 90th Street
- County H between County KR and WIS 20
- Braun Road between
 I-94 and 90th Street
- International Drive from WIS 20 to WIS 11

Temporary jurisdiction was granted because WisDOT has the expertise needed to man-



age large and complex projects with multiple roadways and tight utility coordination time frames. WisDOT has significant construction planned in the I-94 corridor, and one entity coordinating all road construction in the area will be most efficient and cost effective.

Proposed improvements include reconstructing County KR, County H and Braun Road as multilane, divided, urban roadways with storm sewer and

a shared-use path. Reconstruction will also include traffic signals at key intersections.

The project will extend International Drive as a multilane, divided, urban roadway with storm sewer, and a multi-use trail from its existing southerly limit to WIS 11.

WIS 11, from 56th Road to County H, will also be reconstructed to an urban, multilane roadway with storm sewer.

At today's meeting ...

 WisDOT has optimized roadway designs to meet the traffic demands, resulting in fewer lanes.

RACINE COUNTY ROAD IMPROVEMENTS

Protecting the Environment

WisDOT and the Wisconsin Department of Natural Resources (DNR) are jointly addressing environmental issues including the following:

- Wetlands
- · Water resources and quality
- Floodplains
- · Threatened and endangered species

Through the WisDOT-DNR cooperative agreement, DNR identifies and recommends design and construction practices that comply with environmental and regulatory rules. When WisDOT cannot completely avoid impacts, WisDOT will continue to coordinate with DNR to identify measures to mitigate impacts.

The U.S. Army Corps of Engineers (USACE), the Wisconsin Department of Agriculture, Trade and Consumer Protection, and the Southeast Wisconsin Regional Planning Commission also review the project.

WisDOT completed wetland delineations and surveys for historic and archeological resources to support the department's Section 404 permit applications to USACE – the first of which WisDOT submitted in early March. WisDOT will mitigate wetland impacts at a 2:1 ratio, meaning that for every 1 acre of impacted wetland, the department will provide 2 acres of mitigated wetlands. WisDOT has also completed Phase I Hazardous Materials Assessments to identify areas of potential contamination.


Construction Staging and Traffic Control

Braun Road and County KR between the East Frontage Road and County H will be built in stages to accommodate traffic; however, Braun Road will be open only to development-construction traffic and area residents. WisDOT will maintain access for residents along the south side of County KR throughout construction, except for short-duration daytime closures necessary for localized construction.

Staging and traffic control for the remaining work is still under development and will be shared at future public involvement meetings.

Estimated Contract Packages and Construction Years


The map below shows road improvements to accommodate the development site (Areas 1, 2, 3). Roadway staging is preliminary and subject to change. "JT" stands for "jurisdictional transfer," indicating roads for which jurisdiction has been temporarily transferred to WisDOT until reconstruction is complete.



Project Schedule

- WisDOT anticipates the reconstruction of International Drive, Braun Road and County KR to begin in late summer 2018 and be completed in 2019.
- Wisconn Valley Way and WIS 11 between the East Frontage Road and County H will be reconstructed in 2019.
- County H will be reconstructed in 2020.
- WIS 11 west of the West Frontage Road, and Braun Road and County KR east of County H will be reconstructed in 2021.

WisDOT will coordinate work on road improvements with anticipated work on I-94 and area developments to accommodate freeway diversion and local traffic, construction-worker access, construction-material delivery, and utility work.



Development Site Construction Access

Access to the development site (Areas 1, 2 and 3 on the map at right) will be from Braun Road and County KR.

Materials hauling and truck traffic will access the site via Braun Road from County H; all other worker and general traffic will access the site from County KR.

WisDOT will maintain access routes to and from I-94, Racine, Kenosha and the development site in coordination with I-94 construction events and development roads reconstruction.
