#### Discussion:

#### 1. Introduction:

Vincent Fisher provided an overview of the agenda and a description of the purpose of the meeting. Crystal Wilson highlighted previous meeting minute highlights from February 2019.

- 2. Kim Schauder provided SW Mega 139/90 Construction Update:
  - 10-miles of the highway are open without construction, the 3 lanes will not be open at this time.
  - Next year segment north of Janesville will be open
  - Verona road construction will continue in to 2020 2021
  - Janesville Highway 14/26 will start
  - I43 WIS 81 interchange in Beloit half way complete last year
  - Construction of core of interchange where I39/90 meets WIS 81 will be let this summer.
  - · Entrance into Beloit from I43 will not be the connection and Hart Road will have a new connectection
  - · All interstate exits will be free flowing
  - WIS 81 to Milwaukee street will have its own interchange with I39/90 and there will be a diverging diamond

#### 3. Vincent Fisher Rock Stakeholder meetings and OBOEC updates:

DBE program articles & hot topics in DBE Program — Vincent read the first paragraph in the article and highlighted the key challenges in the program for 2019: Uniformity of Practices; Program Resource Allocation, Oversight, and Counting DBE Utilization toward Contract Goals. There was a recent visit from Federal Highway Administration(FHWA) central office, to conduct a Federal Technical Assistance Onsite. The OBOEC office, senior management, and the secretary office meet with FHWA for 3 days. Civil Rights is the focus, and during the FHWA Onsite visit they covered many topics. FHWA covered goal setting, good faith efforts (GFE), prompt payment, retainage, commercially useful function(CUF), DBE certification, interstate certification, and the trucking program. This was not an audit, but to assist with the DBE program FHWA focus on the Civil rights component was emphasized, and they made it clear that contractors are not able to contract out the law.

**Commercial Useful Function (CUF)**: New efforts are being made to complete CUF reviews regarding the usage of DBE firms on federally funded projects. As a recipient of federal funds WisDOT is required to monitor this area of the DBE program. The OBOEC office is coordinating with project staff to implement CUF Reviews on active federally-funded projects, and project managers will be responsible for completing reviews when consulting staff is unavailable.





4. Vincent Fisher Stakeholder Engagement: WisDOT has attended one meeting the Rock County Transportation Coordinating Committee Meeting and plans to attend a Community Steering Meeting in the future. The new DBE section Chief, Madalena Maestri, will have to look at the meetings to see what the next steps for the Rock County Stakeholder Committee. There hasn't been any further direction to move this meeting to another platform yet. For the Verona Road Stakeholder meetings, the project team along with the DBE Program Chief determined to end the meetings and participate in the CWDA Meetings instead. The Rock County Committee can consider what platform to use to continue to most effectively and strategically promote labor and business opportunity in the region related to the 139/90 project.

#### 5. Forward Services Update TrANS Program:

- Rock County TrANS classes started in February and at the end of March
- Dane County TrANS class started on March 1
- 24 Trainees
- 12 Rock County Trainees
- 6 have completed graduation requirements
- 5 Grads hired or are waiting for a hire date
- · 13 students have been placed in Rock County
- · Several more students hired, 3 were from Rock County

#### Trans Placement Report Recall & Rehire:

- 13 people started work in March & April
- 8 of the workers were recalls and most of them are apprentice
- · KK Trucking (Part of Dane County Contracting) is providing more time for workers to get apprenticeship classes done
- Trierweiler wants to make sure females are represented and they are looking to help them get started in the construction field

#### **Rock Enrollment Graduate Report:**

- · When Rock class ended there was one opportunity to take the Accuplacer test on March 4th
- 7 others have passed portions of the test

**TrANS Grad Story**: Tyson attended the Rock County class, he participated in the Operation Engineer open house. Tyson was one of the Rock county grads that was selected to be interviewed by reporters and his story was put in the operation engineer newsletter. Anthony's story: Channel 3 was out on the I39/90 project to watch and speak with workers about National safety week. Rock Roads was a point of contact, and channel 3 interviewed Anthony on the project site about safety on the job.

Questions/Comments: Is it possible to have a cumulative report for the entirety of the project with graphs and numbers of how many TrANS graduate there are, and how many were placed or recalled on the projects? The group would like to see the success in the program since the work started. Forward Service has provided regional reports to WisDOT but not specified by county. Forward Services confirms there were 20 placements at the beginning of last year. Overall there have been 95 placements, the numbers clearly show that there has been progression. Reports can be pull from the Civil Rights & Compliance System(CRCS) majority of this information is based on what contractors enter into the system. We can follow the TrANS Grads if they are entered into the system as a TrANS Grad and if we do receive their apprenticeship documentation we also can enter this into CRCS.

6. **Julie Harkinson Trend Analysis:** There have been some technical issues with the head count report and it has been submitted to the IS Business Automation Senior. Until the technical issues have been sorted out the Trend Analysis will be on hold.

#### 7. Upcoming Events:

- Friday, May 17, 2019, SW TrANS networking event will be held at the Dane County Job Center, from 8 am 11 am. There will be 16 contractors attending, smaller businesses and some DBE's.
- Community Action Training Center Job Fair May 8, 2019, 2 pm 4 pm
- The last day for screening in for the Rock County class is May 8, 2019, 12 pm 3 pm at the Beloit Public library.
- Harkinson Consulting and WisDOT will be hosting a Highschool Field Trip with Janesville School District on May 30, 2019. Parker and Craig High Schools will be participating this year. There will be a total of 50 students who will have the opportunity to meet at a field office to speak with Engineers and WisDOT Project Managers about work on the projects. The students will get to ride on the bus and visit multiple projects to see the different types of work and learn about careers opportunities in construction. The students will get to interact with workers and see firsthand some of the work going on the projects down I39/90. This is the second annual field trip scheduled with the I39/90 project and the Rock County School District.

- Lorie will work with getting the additional information and pull the numbers together for TrANS reports.
- Kim will work with the communication group and see if they can pull together some graphics Lorie and Kim will talk further.
- Vincent and Crystal will reach out to members in the group to be invited to other meetings already established in the Rock County
