

# WIS 42 Resurfacing Project (I.D. 4140-19-73)

Business Meeting Town of Gibraltar October 2, 2019

## **Project Information**

The project includes:

- Mill and overlay WIS 42 from Bluff Lane to the YMCA pedestrian crossing.
- Extend sidewalk, curb, gutter, and storm sewer to improve pedestrian safety and access to the Gibraltar Schools, Auditorium, and YMCA. This includes replacement and modifications of the storm sewer outfall located off Shore Road within Peninsula State Park.
- Miscellaneous repairs to curb and gutter, pedestrian curb ramps, storm sewer inlets and manholes, storm sewer pipes, culverts, and sidewalk.
- Storm sewer outfall relocation at Fish Creek Beach.
- Construction of a turn lane and sidewalk along Shore Road.
- Replacement of lighting along WIS 42 from Bluff Lane to the YMCA pedestrian crossing.

## **Business Signing**

The Town of Gibraltar will be handling the coordination of business signing and placement during this project. For additional details, please contact the town office at (920) 868-1714.

Temporary business signing cannot be placed on traffic control devices or state signs. Business signs attached to these devices will be removed.

#### Traffic Control

WisDOT is committed to staging this project in a manner that minimizes impacts to local businesses while completing the project as quickly as possible. The traffic impacts for this project are as follows:

- Mid October 2019 Winter Shutdown
  - WIS 42 southbound will be closed and detoured from Shore Road to County F. Detour will use County E, County A, and County F.
  - WIS 42 northbound traffic will be open to traffic under flagging operations.
  - WIS 42 will remain open in both directions for the weekends of Pumpkin Patch Days in Egg Harbor, Fall Fest in Sister Bay, and Jack-O-Lantern Days in Fish Creek.
  - All other areas of WIS 42 will be open to traffic with flagging during work operations.
- Spring 2020 Memorial Day Weekend 2020
  - WIS 42 will be closed from Shore Road to the YMCA pedestrian crossing. Detour will use County E and County A.
  - Local access will be allowed between Shore Road and County F.
  - No access will be allowed between County F and the YMCA pedestrian crossing. Access to Gibraltar Schools and Auditorium will be from Gibraltar Road.
  - All other areas of WIS 42 will be open to traffic with flagging during work operations.
  - Detour will be modified prior to Memorial Day weekend. The modified detour will use County F and County A.
- Memorial Day Weekend 2020 End of June 2020
  - WIS 42 will be closed from County F to the YMCA pedestrian crossing. Detour will use County F and County A.
  - WIS 42 will remain closed to all traffic between County F and the YMCA pedestrian crossing. Access to Gibraltar Schools and Auditorium will be from Gibraltar Road.
  - No work permitted in Gibraltar from Bluff Lane to Shore Road. WIS 42 will remain open at all times in these sections.
  - All other areas of WIS 42 will be open to traffic with flagging during work operations.
