> INTRODUCTION

The Wisconsin Department of Transportation (WisDOT) is currently working with the Village of Mount Pleasant, Racine County, Kenosha County, and the Village of Sturtevant on the reconstruction of 16.5 miles of state, village, and county roadways around the new Foxconn Development in Racine County.

The Wisconn Valley Development Road project includes:

- Reconstruction of four existing local roads
- Two new north-south roadways
- New signalized intersections
- Lighting, landscaping, and multi-use paths

> UPCOMING PROJECTS

COUNTY KR PHASE II **AUGUST 2020**

County KR, between County H and Old Green Bay Road, will be reconstructed to a 4-lane concrete urban roadway with a median.

SHARED USE PATHS

July 2020

10-foot shared use paths to be constructed, along with lighting and landscaping, throughout the Wisconn Valley Development area.

> UPCOMING CLOSURES

COUNTY H PHASE II

- County H, just south of WIS 11, is scheduled to be closed to traffic late summer through late fall 2020.

COUNTY KR PHASE II

- County KR, between County H and WIS 31, is scheduled to close to traffic late summer 2020 through late summer 2022.
- County KR/90th Street intersection and County KR/County EA intersection scheduled to close to traffic late summer 2020 through late summer 2022.

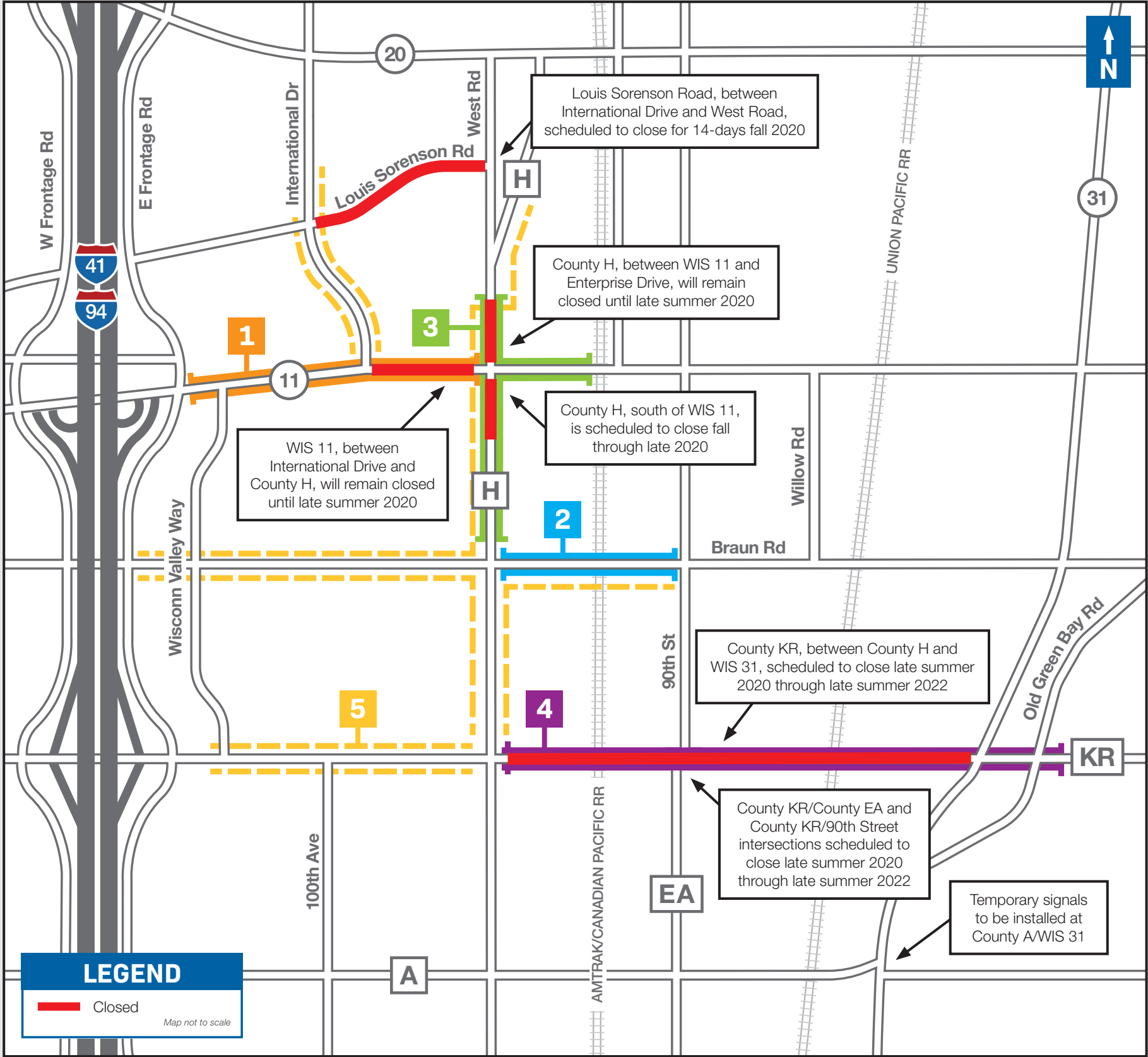

1 WIS 11

Project Overview

WIS 11, between Wisconn Valley Way and County H, is being expanded to a divided roadway with three lanes of traffic in each direction.

2 BRAUN ROAD PHASE II

Project Overview

Braun Road, between County H and 90th Street, is being expanded to a divided roadway with:

- Two lanes of traffic in each direction between County H and the Canadian Pacific Railroad.
- One lane of traffic in each direction between the Canadian Pacific Railroad and 90th Street.

3 COUNTY H PHASE II

Project Overview

County H, between Braun Road and Enterprise Way, is being expanded to a divided roadway with two lanes of traffic in each direction. WIS 11, between County H and the Canadian Pacific Railroad is being expanded to a divided roadway with two lanes of traffic in each direction.

4 COUNTY KR PHASE II

5 SHARED USE PATHS
