General Project Improvements

- Two-year project (April 2021 October 2022)
 - 2021 North Segment (River St to Minerva St)
 - 2022 South Segment (County Shop Rd to River St)
- Improvements
 - New asphalt pavement
 - Intersection geometry & turning movements
 - Sidewalk and pedestrian crossings
 - Water Main, Sanitary Sewer, Storm Sewer

- Street lighting and landscaping
- Bridge Deck replacement
- Modular Block retaining walls
- Box culvert extension


















Overall WIS 23 Project Map













Project Impacts 2021 Construction Season - North Segment

- Full construction season
 - April 2021 to November 2021
- Traffic
 - Detours
 - WIS 23 and WIS 81
 - Staged Construction
 - Local access maintained
 - One lane access across the bridge controlled by temporary signal



















Local Access Definition

2021 Construction Season – North Segment

- Downtown Darlington will be open to two-way traffic north of the bridge over the Pecatonica River
- Allows for access from south of the river to areas such as the Fair Grounds, Hospital, Piggly Wiggly, etc.
- Route is not intended for through traffic, meaning for those with destinations outside the city











Stage 1 Construction 2021 Construction Season – North Segment

- County F/River Street Intersection
 - Reconstruct intersection
 - River Street closed at intersection
 - Traffic on WIS 23 and County F maintained with one-lane traffic with flaggers
 - Pedestrian access plan established for business and residence access
- WIS 23 southbound Cornelia Street to Harriet Street
 - Construct temporary widenings to be used in Stage 2
 - Open to traffic
- Expected work timeframe Beginning to end of April 2021









Stage 2 Construction 2021 Construction Season – North Segment

- WIS 23 northbound County F/River Street to Harriet Street
 - Construct WIS 23 northbound lane and bridge northbound lane
 - Two-way traffic moved to WIS 23 southbound lane
 - Traffic across bridge controlled with temporary signals
 - One lane access across bridge Local and EMS access only
 - All parking on WIS 23 lanes in downtown district suspended
 - Pedestrian access plan established for business and residence access
- Expected work timeframe Late April to late July 2021















Stage 2 Construction 2021 Construction Season - North Segment


















Bridge Deck Replacement

- Replace existing bridge deck
 - ½ at a time to accommodate local traffic and EMS vehicles
- Substructure repairs
- 6-foot sidewalk in both directions
- Steel railing on sidewalk
- Lighting on new bridge deck



















Stage 3 Construction 2021 Construction Season – North Segment

- WIS 23 southbound County F/River Street to Harriet Street
 - Construct WIS 23 southbound lane and bridge southbound lane
 - Two-way traffic moved to WIS 23 northbound lane
 - Traffic across bridge controlled with temporary signals
 - One lane access across bridge Local and EMS access only
 - All parking on WIS 23 lanes in downtown district remain suspended
 - Pedestrian access plan established for business and residence access
 - Expected work timeframe Late July to late October 2021












Stage 3 Construction 2021 Construction Season - North Segment



















Stage 3 Construction (continued) 2021 Construction Season – North Segment

- WIS 23 Harriet Street to Minerva Street
 - Construct WIS 23 lanes
 - WIS 23 from Harriet Street to Minerva Street closed
 - Access maintained for residents and property owners
 - Access residence or property thru Washington Street, Mary Street, Lucy Street or Minvera Street
 - Pedestrian access plan established for business and residence access
- Expected work timeframe Late July to late October 2021












Stage 3 Construction (continued)





Stage 4 Construction 2021 Construction Season – North Segment

- WIS 23 northbound Cornelia Street to Harriet Street
 - Remove temporary widening constructed in Stage 2
 - All lanes of traffic open on WIS 23
 - Parking on WIS 23 southbound lanes reinstated
 - Parking on WIS 23 northbound lanes from River to Cornelia Street reinstated
 - Parking on WIS 23 northbound between Cornelia Street and Harriet Street remains suspended until Stage 4 completion
- Expected work timeframe Late October to mid November 2021














2022 Construction Season

Project Impacts

2022 Construction Season – South Segment

- Full construction season
 - April 2022 to October 2022
- Traffic
 - Detour(s)
 - WIS 23 and WIS 81
 - Staged Construction
 - One stage (Stage 5)
 - Local traffic and EMS access only
 - Bridge and WIS 23 lanes north of River open





















Stage 5 Construction 2022 Construction Season – South Segment

- WIS 23 County Shop Road to County F/River Street
 - Construct WIS 23 lanes
 - All parking on WIS 23 lanes south of the river are suspended until Stage 5 completion
 - Pedestrian access plan established for business and residence access
 - WIS 23 not open to through traffic
 - River St. intersection will be open
 - Encourage motorists to follow the detour route, but local routes are available to get to River St intersection to utilize the bridge
- Expected work timeframe April 2022 to October 2022













Project Detour

- WIS 23 Detour
 - 30.3 miles
 - Darlington to Mineral Point
 - For thru traffic and truck traffic
 - Established prior to Stage 1 construction
 - Removed at the end of stage 4 in 2021 and reestablished before WIS 126 – 5.7 miles construction begins in 2022




















Project Detour

- WIS 81 Detour
 - 25.9 miles
 - Argyle to Darlington
 - Established for thru traffic and truck traffic
 - Established prior to Stage 1 construction
 - Removed at the end of stage 4 in 2021 and reestablished before construction begins in 2022

















Business and Residential Impacts

Businesses

- Parking suspension on WIS 23
 - Downtown Darlington from April 2021 to November 2021
 - Between County Shop Rd and River St from April 2022 to October 2022

Front door access maintained.

- Temporary short-term interruptions to front door access for construction
- Advanced noticed of interruptions



















Business and Residential Impacts

- Pedestrian Access
 - Access maintained
 - Pedestrian access plan for each construction stage
- Residence/Property Access
 - Access maintained
 - Advanced noticed of short-term temporary access disruptions



















Business and Residential Impacts

- Mail Service
 - Contractor to coordinate with Post Office on mail delivery and property owners if necessary
- Waste and Recycling
 - Contractor to coordinate with Faherty for waste and recycling pickup and property owners if necessary











Sanitary Sewer and Water System Impacts

- Sanitary sewer service will not be interrupted, unless there is an emergency
- Property owners will be given 48-hour notice for planned water service outages
 - There may be emergency situations where water is shut-off without notification
 - Special advanced water shutoff notice may be given to businesses upon request please email Mark Digman <u>markdigman@delta3eng.biz</u> with hours of operation and specific needs to request special advanced notification
- When replacing water services for each individual property, the water service will be interrupted for 1-2 hours, unless problems occur – the Contractor will coordinate with property owners prior to replacement
 - If your existing water service is lead or galvanized into the building, then it must be completely replaced into the building to the meter or where the lead or galvanized stops











During Construction

 Field staff will be on-site during construction to address questions or concerns affecting local businesses and residents.


