Project Improvement Information

This portion of the WIS 23 improvement project will reconstruct and raise the profile of the existing four lane portion of WIS 23 from US 151 to Whispering Springs Boulevard, and expand WIS 23 from 2 lanes to 4 lanes from Whispering Springs Boulevard to Seven Hills Road.

Proposed improvements include the following:

- Roundabout at the Intersection of WIS 23 and Wisconsin American Drive
- New interchange at County K
 - Roundabout at the ramp exits and entrances
 - Urban roadway section on County K
 - New access for Mary Hill Park Drive and Hillside Circle
- New interchange at County UU
 - Roundabout at the ramp exits and entrances
 - Park and Ride
- County UU road connections/access improvements
 - Roads 5, 8a, 10, and 11
 - Whispering Springs Drive
 - Irene Drive
 - Northway Road
 - Hilltop Drive
- Restricted Crossing U-Turn Intersections (RCUT)
 - Tower Road
 - 7 Hills Road
- Old Plank Road Trail
 - Continuation of the trail from the city of Sheboygan to the city of Fond du Lac

Real Estate

Right of way acquisition in the form of Temporary Limited Easements (TLEs) and permanent acquisition (FEE) for various locations throughout the corridor will be required. Estimated real estate impacts are shown on the exhibits. Meetings with impacted property owners will be scheduled at a later date as impacts near various properties are being detailed.

Right of way acquisition has already begun and will continue through November 2020.



Proposed Construction Staging

The project is scheduled to be constructed in the years 2021 and 2022. During the construction project, the project objective provides a safe passage for all residents and individuals travelling along WIS 23. WIS 23 will remain open to traffic throughout construction. Local traffic access to residential properties and businesses will be maintained throughout the project. As a result of the construction staging, minor delays will occur to users. The following is an overview describing the preliminary construction staging for the project:

Stage 1 (Construction year 2021)

- WIS 23 and side roads will remain open
 - Construction of Irene Drive, Northway Road, Road 5, Road 8a, Road 10, and Road 11

Stage 2 (Construction year 2021-2022)

- WIS 23 Eastbound lanes from US 151 to County UU
- WIS 23 Westbound lanes from County UU to Seven Hills Road
- Wisconsin American Drive
- County K Interchange
- Mary Hill Park Drive and Hillside Circle Connection
 - WIS 23 will remain open
 - Wisconsin American Drive will remain open
 - Closure of County K and County UU will occur during periods of time
 - Whispering Springs Boulevard and Hilltop Drive access to WIS 23 will be closed

Stage 3 (Construction year 2021-2022)

- WIS 23 Westbound lanes from US 151 to County UU
- WIS 23 Eastbound lanes from County UU to Seven Hills Road
- Continue Construction of Wisconsin American Drive Roundabout
- Construction of County K and County UU Interchanges
- Whispering Springs access road
 - WIS 23 will remain open
 - Wisconsin American Drive will remain open
 - Closure of County K and County UU will occur during periods of time
 - Whispering Springs Boulevard and Hilltop Drive access to WIS 23 will be closed
